Estimates published by United Nations Conference on Trade and Development (UNCTAD) Wednesday said that the slowdown of manufacturing in China due to the COVID-19 outbreak is disrupting world trade and could result in a \$50 billion decrease in exports across global value chains. The most affected sectors include precision instruments, machinery, automotive and communication equipment. Among the most affected economies are the European Union (\$15.6 billion), the United States (\$5.8 billion), Japan (\$5.2 billion), South Korea (\$3.8 billion), Taiwan Province of China (\$2.6 billion) and Vietnam (\$2.3 billion).
